- PSA and returning student-athletes with dusty emails have been rolled over to the new academic year 21-22. Coaches double check your official roster on ARMS.
- Coaches please update your recruiting page.
- Coaches, Countable Athletic Related Activities (CARA) must be recorded on a daily basis and submitted through ARMS every Monday.
- All sports should be following bylaw 17: Sports Season of Competition.
- All head coaches are required to sign their eligibility squad list prior to their first date of competition each semester. Every time there is a roster move a new squad list must be generated and signed. Remember to read your squad list carefully as it contains important information and accuracy is of most importance.

# **OFFICIAL VISITS**

# 10 RULES TO REMEMBER

- 1. Eligibility Prospects must submit transcripts, register with the eligibility center and be placed on TAMIU's request list. Transfers must submit their college transcript.
- 2. 48 hours Official visits cannot last more than 48 hours. The 48 hours begin when the prospects arrive on campus or receives entertainment.
- 3. Lodging Prospects may be provided lodging that is similar to the accommodations provide to regular students. Hotels may be used but at a scale comparable to that of a normal student life and only within a 30-mile radius of campus.
- 4. Student Hosts- Student host may receive \$30 for entertainment of prospects and their families. Students may receive complimentary meals as long as they are accompanying the prospect.
- 5. Admissions Prospects may receive up to 5 complimentary passes via *Pass List* to regular season home athletic competitions.
- 6. Meals Prospect and their relatives or legal guardians may be provided the actual cost of meals.
- 7. Cash Prospects cannot receive cash from boosters, staff members or student hosts.
- 8. Automobiles TAMIU and boosters may not provide an automobile to a prospect.
- 9. Airfare Airfare for commercial transportation for the official visit may not exceed coach (or comparable) class.
- 10. Boosters On-campus contact with a prospects during an official visit are confined to campus.

## REGISTRARS

- Drop requests after census date (09/07/2021) must be submitted through ARMS.
- October 1, 2021: Fall 2021 graduation application and payment deadline. A \$100 late fee will be assessed to students applying after this date.
- October 16, 2021: Mid-Semester
- November 18, 2021: Last day to drop a course or withdraw from the University.
