# NAME, IMAGE AND LIKENESS BRIEF

## NCAA ADOPTS INTERIM NAME, IMAGE AND LIKENESS POLICY

Effective August 6, 2021, NCAA college athletes now have the opportunity to benefit from their name, image and likeness. Governance bodies in all three divisions have adopted a uniform interim policy suspending NCAA name, image and likeness rules for all incoming and current student-athletes in all sports. The policy provides the following guidance to college athletes, recruits, their families and member schools:

- Individuals can engage in NIL activities that are consistent with the law of the state where the school is located. Colleges and universities may be a resource for state law questions.
- College athletes who attend a school in a state without an NIL law can engage in this type of activity without violating NCAA rules related to name, image and likeness.
- Individuals can use a professional services provider for NIL activities.
- Student-athletes should report NIL activities consistent with state law or school and conference requirements to their school.

## TEXAS SENATE BILL 1385 - NAME, IMAGE AND LIKENESS

Effective July 1, 2021. This bill permits student-athletes within the institution to monetize their name, image, and likeness (“NIL”).

- The law requires all student-athletes to disclose all of their NIL agreements to TAMIU.
- The law details that athletes may not enter in a contract if any provision of the contract conflicts with a provision of the student athlete’s team contract, a provision of an institutional contract of the institution, a policy of the athletic department of the institution, or a provision of the honor code of the institution.
- The law also requires a student-athlete participating in an intercollegiate athletic program at the institution to attend a financial literacy and life skills workshop at the beginning of the student’s first and third academic years at the institution.
- The workshop must be at least five hours in duration and include information on financial aid, debt management, time management, budgeting, and academic resources available to the student-athlete.

## OFFICE OF EQUAL OPPORTUNITY AND DIVERSITY

- The NCAA Board of Governors, the Association's top governing body, has expanded its existing association-wide campus sexual violence policy. According to the new policy, all incoming, current and transfer college athletes must disclose annually to their school whether their conduct has resulted in an investigation, discipline through a Title IX proceeding or a criminal conviction for sexual, interpersonal or other acts of violence. A failure by the athlete to accurately and fully disclose investigatory activity, a disciplinary action or criminal conviction may result in penalties, including a loss of athletics eligibility as determined by the school. This change will go into effect the 2021-2022 academic year.
- The Office of Equal Opportunity and Diversity is now offering customized workshops that include Green Dot, Intimate Partner Violence, Healthy Relationships, and Safe Dating.
