# University Research Council Meeting Minutes

January 18, 2008

## I. Call to order

Dr. Jeff Brown called the meeting to order of the University Research Council at 10:05 on January 18, 2008 in KL 330.

#### Roll call

## **II. Approve Minutes**

## VI. Faculty Development Leave

The outcome of the faculty meeting was discussed by the council members. Applications for departmental leave will be solicited in Fall. This will be publicized to gain candidates. There are plans to fund 1 or more developmental leaves per year.

#### VII. Proposed Changes in Research Funding

(a) Increases in IDC funding Short-term and Long-Term
Dr. Brown went over the interlocking proposals for research funding. A
Memo was handed out as an exhibit. This memo is meant to formalize the
percentage of allocated monies. There will be a straight percentage for
sponsored research and a 5% reserve for each following year.

- (b) Salary Savings via grant activity
  Dr. Brown discussed the potential arrangement as 10% of monies going towards an incentive process; limiting faculty.
- (c) Rollover of research accounts

  Dr. Brown explained that this would affect all accounts conservatively; research development funds, individual faculty accounts, etc.

## **VIII. Reapplication Limitations**

- (a) Limit number of years; optional years if funded via grant related salary savings
  - Faculty will be eligible to apply twice in a 5 year period with a provision for those awarded grants to re-apply in subsequent years.
- (b) Reduced amount for year two (or 3), since re-writing/re-submitting a grant is easier?
